

# 2020 Interim Boyne Tannum HookUp Random Prize Draw Rules

These are the interim HookUp rules for the 2020 virtual random prize draws. "Virtual" means there is no face-to-face contact between people, or a physical location for people to meet; because the draws will be conducted at an undisclosed location and shown via digital media. All registrations to enter are electronic via the HookUp website to maintain social isolation.

## 1. Random Prize Draw Registration Details

Dates of Competition: Friday 1st May, Saturday 2<sup>nd</sup> May and Sunday 3<sup>rd</sup> May, 2020

## 1.1 Random Prize Draw Entry Registration

Registrations are available at the Boyne Tannum Hook Up website www.boynetannumhookup.com.au.

#### 1.2 Random Prize Draw Entries Close

Registrations will close daily during the 3-day event at 3pm to be ready for the evening random prize draws that will be conducted from 6pm. This means entries close by 3pm Friday 1<sup>st</sup> May, 3pm Saturday 2<sup>nd</sup> May and 3pm Sunday 3<sup>rd</sup> May, 2020.

### 1.3 Random Prize Draw Entry Fees

Senior Competitor \$90.00 Junior Competitor \$40.00

Junior Competitors must be under the age of 16 years up to and including the last day of the competition (if an entrant's age is not eligible to obtain a boat licence then they are classified a junior) and not under the age of 3 years at the commencement of the competition.

## 1.4 Proof of Ticket

To be eligible to win ANY random prize you MUST produce a copy of the Electronic Ticket provided to all registered competitors on collection of any prizes. All registered competitors will be issued with an Electronic Ticket or a print out of an Electronic Ticket on receipt of their registration.

## 1.5 Refunds

No refunds will be provided.

### 1.6 Event Cancellations:

As a result of the 2020 Covid-19 Global pandemic the HookUp fishing competition is NOT being hosted in Bray Park, Boyne Island to meet the Federal Government and Chief Medical Officer's advice that non-essential gatherings of more than 500 people should be cancelled. Therefore, the fishing competition is NOT being held. However, the random prize draws are being conducted when the number of entry registrations sold reaches 3,000 in total. If the circumstance arises where the number of entries does not meet this normally achieved annual 3,000 entries (in order for HookUp to pay for the boat package prizes), the entries will be held over for the 2021 event.

Entries will be capped at 5,000 in total.



For example: the cost of a senior HookUp registration at \$90 you will have a 1 in 3,000 chance of winning an \$85,000 boat or another smaller prize out of the \$300,000 prize pool.

## 2. Rules and Conditions of Competition 2020

The Boyne Tannum HookUp is normally an annual fishing competition which also includes random Promotional Draws for ticket holders attending the 3-days of activities. Upon paying the entry fee to the fishing competition the entrant is normally entitled to free entry to daily promotional prize draws. However due to the 2020 Coronavirus pandemic the HookUp prizes are going to be drawn randomly with an independent adjudicator overseeing the electronic and barrel draws under the approved Queensland Government Gaming Regulation Licence.

The Boyne Tannum HookUp Association Inc's Committee Management is responsible for the Boyne Tannum HookUp event. These rules and conditions of the competition may change from year to year. It is the responsibility of the competitor to review the rules and conditions each year. The Boyne Tannum HookUp Association will endeavour to inform participants of annual changes however hold no responsibility for individuals not knowing and understanding the rules.

NOTE: During 2020 there is no fishing competition. Therefore, no entrant weighs in a fish anywhere for HookUp.

## 2.1 Eligibility to Enter the Competition

The general public including HookUp contractors, stall holders, volunteers, sponsors, past committee members and families of current committee members are eligible to enter the Boyne Tannum HookUp. The current sitting HookUp Committee Members are ineligible to enter the competition.

HookUp prizes are going to be drawn randomly with an independent adjudicator overseeing the electronic and barrel draws under the approved Queensland Government Gaming Regulation Licence.



#### 2.2 Random Prize Draws

On each prize draw the entrant possessing the electronic ticket number announced will be contacted by the committee and arrangements made to collect their prize by Monday 11th May, 2020 from the Gladstone Region or transport can be arranged at the entrant's cost.

All prize winners will also require formal identification upon presenting themselves to collect their prize. All junior prize winners will be accompanied by a parent or carer with formal identification to confirm the winner's identification.

Once a prize has been drawn and announced that electronic ticket number will be returned to the barrel or electronic randomiser software and another draw will occur immediately. This means an entrant can win more than one prize each night or over the 3 evenings.

NOTE: All prize draws will be live streamed via the HookUp Facebook page each evening from 6pm and winners will be contacted to collect their prize – there is no timer and no requirement to be present at the draws or even watch the draws to see if you win.

### 2.3 The Random Prize Draw Entrant

Under the condition that the Boyne Tannum HookUp holds a Queensland Government Gaming Regulation Licence, the Random Prize Draw Entrant shall comply with:

- One registration ticket per person into the Random Prize Draws
- Under no circumstances are there to be any transfer of Official Electronic Ticket to another name prior to or during the event;
- As a Random Prize Draw Entrant you authorise, give permission for Boyne Tannum HookUp Management Committee for use of any audio/visual imagery taken of yourself via photography, video content, drone footage and audio recordings, name, to be used for purposes of material produced for education, promotion, marketing or advertising for (included but not limited too) print, media releases, radio, TV, website, social media, graphics, editorials, banners, stickers, shirts, corf lutes, street signs. Also, unless otherwise stated, there will be no restrictions on the geographical distribution of material produced;
- If you have a child/ren under the age of 18 years old, you give permission and all rights for Boyne Tannum HookUp committee for use of any audio/visual imagery taken of child/ren via photography, video content, drone footage and audio recordings, name, to be used for purposes of education, promotion, marketing or advertising for (included but not limited too) print, media releases, radio, TV, website, social media, graphics, editorials, banners, stickers, shirts, corflutes, street signs. Also, unless otherwise stated, there will be no restrictions on the geographical distribution of material produced. If the minor is under the laws of the state where his/hers appearance is recorded.
- By completing The Boyne Tannum HookUp website registration process:
  - You have read the Boyne Tannum HookUp Terms and Conditions of the Competition presented; and
  - You understand the terms described and are lawfully abiding by these terms and conditions granting Boyne Tannum HookUp Association rights given under this contract.

### 2.4 Disputes

In the event of any dispute or any differing interpretation of the rules and conditions of the Boyne Tannum HookUp competition, the competitor may write to the Boyne Tannum HookUp stating their dispute. The Boyne Tannum HookUp Management Committee will hear the dispute after the competition is completed providing the disputing competitor a fair hearing. The disputing competitor will be advised in writing of the outcome of the Management Committee regarding the dispute. The management committee decision is final.
